CALL TO ORDER By Trustee Connolly-7:00pm/ PLEDGE OF ALLEGIANCE/ ROLL CALL: Bower, Connolly, Karow, Knoll, Moran, Stoen present. Skinner absent. Village Administrator David Cox, Police Chief Dale Racer and Clerk/Treasurer Kathleen Richardson also in attendance.

DISCUSSION/ACTION WITH REGARD TO AN EVIDENTIARY HEARING FOR MICHELLE DI MEO REGARDING THE DENIAL OF ISSUANCE OF AN OPERATOR'S LICENSE

Michelle DiMeo was in the audience and spoke to the Board. She stated that she didn't understand the questions the form, had marked them wrong, and now wanted to correct them. DiMeo states that she currently holds a license in Bloomfield. Chief Racer stated he had spoken with Ms DiMeo regarding the denial and she said she had forgotten about her past record to which Chief stated this is pretty traumatic to forget. Chief also spoke with the Bloomfield Police Department and DiMeo will be satisfying the fines owed over the next 30-60 days. Chief stated that his position has not changed in this matter.

Motion by Stoen to again deny the issuance of the operator's license to Michelle DiMeo based on the information received from the Police Chief. Cox stated the motion should be made to uphold the denial (in the affirmative).

Amended motion by Stoen, Karow, carried, to uphold the previous decision of denial of an operator's license to Michelle DiMeo.

Due to the fact that this license is being denied due to untruthfulness in the completion of the application, it will be a two year period before Ms DiMeo can apply with the Village again (2/09). Karow wanted to express appreciation to Ms DiMeo for coming tonight to appear before the Board.
