#### 10.04.020 State Statutes Adopted.

A. State Traffic Forfeiture Laws Adopted. Except as otherwise specifically provided in this Title, all provisions of Chapters 340 to 348 of the Wisconsin Statutes and Chapter Trans 305 of the Wisconsin Administrative Code describing and defining regulations with respect to vehicles and traffic for which the penalty is a forfeiture only, including penalties to be imposed and procedure for prosecution, are adopted and by reference made a part of this Chapter as if fully set forth herein. Any act required to be performed or prohibited by any statute incorporated herein by reference is required or prohibited by this Title and Code. Any future amendments, revisions or modifications of the statutes incorporated herein are intended to be made a part of this Code in order to secure uniform statewide regulation of traffic on the highways, streets and alleys of the state of Wisconsin.

#### **10.08.010 Enforcement Generally.**

A. This Title shall be enforced in accordance with the provisions of Sections 345.20 to 345.53, Chapter 299 and Section 66.12 of the Wisconsin Statutes.

B. Stipulation of Guilt or No Contest. Stipulations of guilt or no contest may be made by persons arrested for violations of this Title in accordance with Section 66.12 (1) (b), Wisconsin Statutes, whenever the provisions of Section 345.27 are inapplicable to such violations. Stipulations shall conform to the form contained on the uniform traffic Citation and complaint under Section 345.11, Wisconsin Statutes, and may be accepted within ten (10) days of the date of the alleged violation. Stipulations may be accepted by the Village Police Department. (Ord. 85-10-152(a) and (b), 1985: § 11(1) of Ord. passed 9/11/72).

#### **10.08.020 Deposits.**

Any person stipulating guilt or no contest under Section 10.08.010 must make the deposit required under Section 345.26, Wisconsin Statutes, or, if the deposit is not established under such statute, shall deposit a forfeited penalty as provided in the schedule established by the Chief of Police and approved by the Village Board. Deposits may be brought or mailed to the office of the Police Department as directed by the arresting Officer. Deposits for parking or nonmoving violations shall be mailed or brought to the Village Police Department. (Ord. 85-10-1 § 2(c), 1985: § 11(2) of Ord. passed 9/11/72).

#### **10.08.030 Notice Of Demerit Points And Receipt.**

Every Officer accepting a forfeited penalty or money deposit under this Title shall receipt therefor in triplicate as provided in Section 345.26(3) (b), Wisconsin Statutes. Every Officer accepting a stipulation under the provisions of this Title shall comply with the provisions of Sections 343.27, 343.28, 345.26(1)(a) and 345.27(2), Wisconsin Statutes, and shall require the alleged violator to sign a statement of notice in substantially the form contained on the uniform traffic Citation and complaint promulgated under Section 345.11 Wisconsin Statutes. (§ 11(3) of Ord. passed 9/11/72).

#### **10.08.040 Officer's Delivering Penalties--Oath And Bond.**

Any Officer accepting deposits or forfeited penalties under this Title shall deliver them to the Village Clerk/Treasurer within twenty (20) days after receipt. Any Officer authorized to accept deposits under Section 345.26, Wisconsin Statutes, or this Title shall qualify by taking the oath prescribed by Section 19.01, Wisconsin Statutes, and filing an official bond in the sum of one thousand dollars (\$1000.00) as described by Section 19.01. (§ 11(4) of Ord. passed (9/11/72).

The operator of any vehicle involved in an accident shall within ten (10) days after such accident file with the Village Police Department a copy of the report required by Section 346.70, Wisconsin Statutes, if any. If the operator is unable to make such report any occupant of the vehicle at the time of the accident capable of making such report shall have the duty to comply with this Section. Such reports shall be subject to the provisions and limitations in Sections 346.70(4)(f) and 346.73, Wisconsin Statutes. (§7 of Ord. passed 9/11/72).

#### **10.20.010 Erecting And Maintaining Signs And Signals.**

The Department of Public Works is authorized and directed to procure, erect and maintain appropriate standard traffic signs, signals and markings conforming to the rules of the state highway division giving such notice of the provisions of this Title as required by state law. Signs shall be erected in such locations and manner as the Department of Public Works shall determine will best effect the purposes of this Title and give adequate warning to users of the street or highway. (§ 9(1) of Ord. passed 9/11/72).

#### **10.20.020 Removal Of Unofficial Signs Or Signals.**

The Department of Public Works shall have the authority granted by 349.09, Wisconsin Statutes, and is directed to order the removal of a sign, signal, marking or device placed, maintained or displayed in violation of this Title or Section 346.41, Wisconsin Statutes. Any charge imposed on a premises for removal of such an illegal sign, signal or device shall be reported to the Village Board at its next Regular Meeting for review and certification. (§ 9(2) of Ord. passed 9/11/72).

## Chapter 10.24

### THROUGH HIGHWAYS AND ONE-WAY STREETS

In the interest of public safety and pursuant to Section 349.07, Wisconsin Statutes, the following streets or portions thereof are declared to be through streets:

- A. North Lake Avenue from Main Street to Village limits;
- B. Burlington Avenue north from West Main Street to Village limits;
- C. Legion Drive from South Lake Street east to Village limits;
- D. Wilmot Road from South Lake Street to Village limits;
- E. East Lake Shore Drive from Wilmot Road to State Line Road;
- F. Lance Drive from Main Street west to Village limits;
- G. Musial Road from Lance Drive East to Lake Street;
- H. Main Street from Lake Street west to Village limits.(Ord. 85-10-1§4(part): § 3 of Ord. passed 9/11/72).

#### 10.24.020 One-Way Streets.

Pursuant to Section 349.10, Wisconsin Statutes, the following street and/or parts thereof are declared to be one-way streets, and no person shall operate any vehicle thereon except in the indicated direction. Emergency and snow plow vehicles/equipment are exempted from this provision.

- A. Waldeck Drive, east from south Waldeck Drive to Indian Point Road. This is from 405 to 454 Waldeck Drive.
- B. Frontage Road adjacent to and parallel to Lance Drive, eastbound from Bay View Avenue to its terminus approximately seven hundred and seventy five (775) feet to the east. (Ord. 2001-6-3; Ord. 98-4-3: Ord. 90-5-1; Ord. 90-4-2; Ord. 85-10-1 § 4(part): § 4 of Ord. passed 9/11/72).

#### **10.28.010 Definitions**

- A. Non-Moving Violation shall mean any parking of a vehicle in violation of a statute or local Ordinance.
- B. Parking Citation shall mean the paper form designated by the Chief of Police required for use in enforcing the Non-Moving Violations created or adopted in this Chapter in accordance with § 66.0113 of the Wisconsin Statutes. Such parking Citation shall contain:
  - 1. A printed explanation of the procedure for either paying or contesting the Citation.
  - 2. A printed warning that nonpayment may result in the suspension of current and the denial of future vehicle registrations for the registered owner of the vehicle cited.
  - 3. The location, date and time of the violation.
  - 4. The vehicle registration information, including the license plate number, state, expiration, vehicle make and year.
  - 5. A specific reference to the Ordinance violated and the forfeiture associated with that violation.
- C. Suspending Authority shall mean the Twin Lakes Police Department who shall be responsible for submitting requests to the TVRP for registration suspension for unpaid parking Citations. The person authorized to sign suspension forms shall be the Chief of Police or his/her designee.
- D. TVRP shall refer to the Wisconsin Department of Transportation Traffic Violation and Registration Program. (Ord. 2010-9-2)

#### **10.28.020 Parking Regulations And Penalties.**

- A. Pursuant to § 349.06, Wis. Stats., the Village of Twin Lakes has the authority to enact and enforce the parking regulations, also referred to as "Non-Moving Violations," in conformity with §§ 346.50 to 346.55, Wis. Stats.; and that in addition to those regulations directly referenced by statute, regulations restricting parking under this Title have been created; and that the penalties and provisions for those Ordinances and adopted statutes shall be governed by this Title in conformity with § 345.28, Wis. Stats.
- B. Non-Moving Traffic Violation and Registration Program. Pursuant to the provisions of § 345.28(4), Wis. Stats., the Village of Twin Lakes is authorized and elects to participate in the Non-Moving Traffic Violation and Registration Program (TVRP) of the Wisconsin Department of Transportation and pay the costs established by the Department under § 85.13, Wis. Stats. Such costs shall, in turn, be assessed against persons charged with non-moving violations. The Chief of Police shall be responsible for complying with the requirements set forth in § 345.28(4), Wis. Stats.

C. The penalty for violation of this Chapter shall be forfeiture in the amount set forth in Chapter 10.48 of this Code in conformity with § 346.56, Wis. Stats.; plus any applicable court costs which may be imposed by the Municipal Court in accordance with § 814.65(1), Wis. Stats. for contested violations, plus any fees or charges authorized under § 345.28(4)(d) for unpaid Citations where the vehicle registration has been submitted to the TVRP for suspension. (Ord. 2010-9-2)

#### **10.28.030 Citation Procedure**

A. Upon issuance of a Citation, a person charged with a non-moving traffic violation under this Section may make a deposit of money to the Twin Lakes Police Department by mail, by electronic means authorized by the agency, or in person, in which case the Citation shall not be filed with or transmitted to the Municipal Court, and no further action is required of the person charged.

B. A person charged with a non-moving violation under this Section has the option to contest the Citation by giving notice in writing to the Twin Lakes Police Department. The registered owner of the vehicle shall forfeit his/her right to contest the Citation if such notice is not received by the agency within 28 days of the initial notice date sent.

C. If the person charged gives notice of his/her desire to contest the Citation, the Citation shall be submitted to the Municipal Court pursuant to § 345.30, Wis. Stats., and the procedures under §§ 345.34 to 345.47, Wis. Stats., will apply.

D. Notice.

1. If payment for the Citation is not received by the Twin Lakes Police Department within thirty (30) days of the date of issue and a request to contest has not been received by the agency, the forfeiture amount for the violation shall be double, and a notice will be sent to the last known address of the registered owner of the vehicle cited.

2. The notice shall include the date the Citation was issued, the license number of the vehicle involved, the place or manner in which the Citation may be paid, the means by which the Citation may be contested, and the date by which the person must pay or contest the Citation to avoid further action by the Police Department.

E. If the Citation remains unpaid after fourteen (14) days of the first notice, and no request to contest the charge has been received, a second notice will be sent to the last known address of the registered owner of the vehicle cited.

F. If, after fourteen (14) days of the second notice, the Citation remains unpaid and a request has not been received to contest the Citation, the Twin Lakes Police Department may proceed under § 345.28, Wis. Stats., to suspend the registration and deny future registration until the amount of the forfeiture plus any authorized fees and costs are paid.

G. If the person subsequently pays the forfeiture and any fees and costs, the Twin Lakes Police Department shall send written notification to the TVRP within three (3) working days that payment has been satisfied so that the suspension and/or refusal of future registrations will be lifted.

H. In the event that a vehicle cited under this Section is a vehicle registered in a state other than Wisconsin and if the owner fails to pay any parking Citation, the Chief of Police shall be authorized to utilize a commercial collection firm to collect the outstanding forfeiture, along with any authorized fees or costs.

I. Any vehicle parked in violation of Chapter 10.28 may be towed at the direction of the Chief of Police, or their respective designees. The owner of a towed vehicle shall be responsible for all towing and storage charges in addition to any forfeitures. (Ord. 2010-9-2)

#### **10.28.040 Parking Limits.**

When signs are erected in any block giving notice thereof, no person shall park a vehicle for longer than the period hereinafter specified.

A. Between the hours of ten (10:00) p.m. to six (6:00) a.m.:

1. East side of Wilmot Avenue between Lavera Parkway and Sunset Trail;
2. East side of Wilmot Avenue at intersection of Wilmot Avenue and Lake Street.

B. Between the hours of two (2:00) p.m. and two (2:00) a.m.:

On South Lake Avenue from the intersection of Wilmot Road to Barry Street.

(Ord. 85-10-1 § 5 (part) : § 5(1) of Ord. passed 9/11/72).

**10.28.050 Regulation of Prohibited Parking.**

No operator of any vehicle shall park or stop a vehicle otherwise than in obedience to traffic regulations, signs, signals or markings whether such vehicle is occupied or not, in any of the following places:

- A. Within an intersection.
  - B. On a crosswalk.
  - C. In any designated safety zone, or within fifteen (15) feet of a designated safety zone.
  - D. On any sidewalk or sidewalk area, or area painted to indicate a sidewalk.
  - E. Double-parking on the side of any street or roadway.
  - F. Entrance to the fire station on the north side of East Main Street, or across the street from the fire station on the south side of East Main Street twelve (12) spaces, or five (5) spaces on the north side of East Main Street nearest the fire station in front of 248 East Main Street. This subsection shall not apply to operators of authorized emergency vehicles, which shall include privately owned motor vehicles used by members of the Twin Lakes Fire Department while en route to a fire or on an emergency call pursuant to orders of their Chief or other Commanding Officer.
  - G. In front of school buildings between seven-thirty (7:30) a.m. and four-thirty (4:30) p.m. on school days.
  - H. In any public or private alley, except for the purpose and time required to load and unload passengers or materials.
  - I. Upon streets which have been marked or in places signed for angle parking, other than at the angle to the curb indicated by such marks or signs.
  - J. Within twenty (20) feet of the approach to any stop sign or traffic control signal located at the side of a roadway or in any area of painted yellow curb unless otherwise indicated by signs or markings.
  - K. Alongside or opposite any street excavation or obstruction when stopping, standing or parking would obstruct traffic.
  - L. At any place where official signs prohibit parking.
  - M. Within four (4) feet of the approach or within four (4) feet beyond an alley or driveway.
  - N. Contrary to posted rules in any public parking lots.
  - O. Contrary to the restrictions on stopping and parking as enumerated in the provisions of Sections 346.50 to 346.55 of Wisconsin Statutes.

**10.28.060 Prohibited Parking--Fire Lanes.**

There shall be no parking in any fire lane, as indicated by the posting of “no parking” signs on said fire lanes. “No parking” signs shall be posted on fire lanes with the approval of the majority of the Village Board, and a master list of posted fire lanes shall be maintained by the Village Clerk/Treasurer/Treasurer at the Village Hall. (Ord. 92-2-1).

**10.28.070 Stop Streets.**

All vehicles shall come to a complete stop before entering or proceeding on streets or intersections that have posted stop signs. All stop signs shall be approved by a majority vote of the Village Board prior to posting, and a master list of all approved stop signs shall be maintained by the Village Clerk/Treasurer at the Village Hall. (Ord. 92-1-2)(Ord 2018-5-2).

### **10.28.080 Parking Limitations.**

A. The following parking limitations are established, and there shall be no stopping, standing or parking at any time in any of the following areas which are posted with signs that restrict parking:

1. Bay View Avenue.

Lift station at 525 Bay View Avenue;

2. Oak Ridge Drive.

South side of Oak Ridge Drive, east of Elm Court;

3. South Lake Avenue.

East side from 410 to 430 South Lake Avenue;

4. Lucille Avenue.

East side, north of 1148 Lucille Avenue;

5. Musial Road.

East side, at termination of street at Musial Beach;

6. Dietrich Drive.

East side, at termination of street;

7. Lakeshore Way.

East side, by boat landing;

8. Elm Street.

East side, at termination of street;

9. Kennedy Drive.

10. Frontage Road adjacent to and parallel to Lance Drive, from the east terminus to the west one hundred seventy five (175) feet.

No parking on either the north side or the south side of Kennedy Drive from the intersection of North Lake Avenue east three hundred eighty-five (385) feet.

11. There shall be "NO PARKING" on the east side of the 600 block of Park Avenue one hundred fifty (150) feet up from the intersection of Hwy Z and Park Avenue.

12. There shall be "NO PARKING" on the Sunset Court cul du sac.

13. There shall be "NO PARKING" on the north side of Basset Street.

14. There shall be "NO PARKING" on the west side of Upper Horseshoe Drive.

15. There shall be "NO PARKING" on the north side of E/W Richter Court.

16. There shall be "NO PARKING" on the both sides of Strickland Avenue.

17. There shall be "NO PARKING" adjacent to 128 E School Street

B. There shall be no stopping, standing or parking in any of the following described areas which are posted with "NO PARKING THIS SIDE OF STREET" signs:

1. Schoors Lane.

North side, for thirty (30) feet from the intersection of East Lake Shore Drive;

2. Pawley Avenue.

East side, from the intersection of Pawley and Roseanne Court to the intersection of Lance Drive and Pawley Avenue;

West side, from intersection of Lance Drive to 111 Pawley Avenue;

3. Bay View Avenue.

West side, from Lance Drive to Knobes Avenue;

West side, from the lift station south to Pine Street;

West side, from Highland Drive to the pedestrian bridge;

4. Knobes Avenue.

North side, from 300 to 304;

5. Indian Point Road.

South/West side, from 411 to 349;

North/East side, from across from 411 to 349;

South side, 601 to 605 Indian Point Road at intersection of Rosebud Avenue and Indian Point Road;

6. Barry Road.

There shall be no parking on either the north side or the south side of Barry Road from the intersection of South Lake Avenue eastward to Wilmot Avenue;

7. Wilmot Avenue.

East side, from Municipal lot to intersection of Barry Road and Wilmot Avenue;

8. Lakeview Avenue.

South side, from Lakeview and South Lake Avenue to Lakeview and Wilmot Avenue;

9. South Lake Avenue.

West side, from Barry Road to Wilmot Avenue;

East side, from intersection of South Lake Avenue and Wilmot Avenue to and including 410 South Lake Avenue known as the Edgewater Beach Condominiums;

10. East School Street.

North side, from Burlington Avenue to Strickland Avenue;

11. Police Department -- Emergency vehicles only.

Police Department parking lot, west side of building;

12. Musial Road.

South side, east of Haerle Avenue;

13. Haerle Avenue.

West side of Haerle Avenue south from the intersection of Musial Road one hundred fifty (150) feet;

14. Wilmot Avenue.

West side of Wilmot Avenue from the intersection of Lakeview Avenue to and including the rear of the property at 410 South Lake Avenue known as the Edgewater Beach Condominiums and from the intersection of South Lake Avenue and Wilmot Avenue to the intersection of Wilmot Avenue and East Lake Shore Drive.

East side of Wilmot Avenue from intersection of Legion Drive to East Lake Shore Drive;

15. Legion Drive.

North and south side from South Lake Avenue east to Village limits;

16. Lincoln Drive.

East and west side from Roosevelt Road south to Gatewood Drive;

17. Park Avenue.

West side, from intersection of West School Street south seventy-five (75) feet;

C. There shall be no stopping, standing or parking in any of the following posted designated areas:

1. No Parking in Driveway.

North side of street at intersection of Strickland and East School Street;

2. No Parking Here to Corner.

North side of Lake Street, seventy-five (75) feet to Wilmot Avenue;

South side at 350 East Main Street to South Lake Avenue;

3. No Parking Between Signs.

West side of Wilmot Avenue from 603 to 703 Wilmot Avenue;

4. No parking east side of North Lake Avenue, from utility pole number 100, for a northerly distance of forty-one (41) feet.

D. There shall be no parking, standing or stopping on the north side of Lance Drive from the intersection of Bay View Avenue as extended to the north line of Lance Drive, easterly for a distance of nine hundred (900) feet, between the hours of eight (8:00) a.m. and five (5:00) p.m., except Saturdays, Sundays and holidays.

E. Parking shall be limited to two (2) hours in duration on weekdays between nine (9:00) a.m. and five (5:00) p.m. in the following areas which are posted with signs that restrict parking:

1. North side of East Main Street from Burden Avenue to North Lake Avenue;

2. West side of South Lake Avenue from Legion Drive to Lakeview Avenue.

F. Parking shall be further limited to two (2) hours in duration on Saturdays between nine (9:00) a.m. and five (5:00) p.m. in the following areas which are posted with signs that restrict parking:

1. North side of East Main Street from Burden Avenue to and including 316 East Main Street.

G. Loading Zone or Drop Off/Pick Up restrictions limiting the maximum duration of parking, stopping or standing are hereby established as follows upon posting of proper signage:

1. Two (2) parking spaces in front of the business located at 344 East Main Street for a duration of fifteen (15) minutes between the hours of eight (8:00) a.m. and five (5:00) p.m. on Monday through Saturday. (Ord. 2018-5-2; Ord. 2014-1-1 (A.13,14,15,&16); Ord.2013-3-1 (A. 11 & 12) part; Ord. 2012-3-1 (G) ); Ord. 2009-5-2; Ord. 2004-9-2; Ord. 2003-11-2; Ord. 2003-1-1 § 4; Ord. 2001-7-2; Ord. 97-12-2; Ord. 97-8-1; Ord. 97-7-5; Ord. 95-2-1; Ord. 94-7-1; Ord. 92-10-1; Ord. 91-10-1; Ord. 90-4-4; Ord. 89-5-2; Ord. 88-4-2; Ord. 87-6-1; Ord. 86-9-1; Ord. 85-10-1 § 5 (part): § 5(3) of Ord. passed 9/11/72).

**10.28.090 Handicapped Parking Zone.**

Except for a motor vehicle used for a physically disabled person as defined by Section 346.503(1) Wisconsin Statutes, no person may park, stop or leave standing any vehicle whether attended or unattended, and temporary or otherwise, upon any portion of a street, highway or parking facility reserved by official traffic signs indicating a restriction for vehicles displaying special registration. (Ord. 97-8-2: editorially amended per approval by Village Board 7/8/96; Ord. 86-8-1).

**10.28.100 Boat Launch Facilities.**

No person, firm or corporation shall park or be allowed to park any vehicle that has been used to launch a watercraft at any boat launch, as defined elsewhere in this Code, without properly displaying a proper permit for said use of boat launch facilities.(Ord. 2007-7-2)

**10.28.110 Snow Emergency.**

A. No person, firm or corporation shall park or be allowed to park any vehicle in any street, road or alley in the Village within a period of forty-eight (48) hours after a two (2) inch or more snowfall.

B. If any person, firm or corporation shall allow any vehicle to remain on any street or road after a period of two (2) hours after two (2) inches or more of snow has fallen, maintenance personnel and/or the Police Department shall order the same removed and the vehicle impounded until the cost of removal and forfeiture hereinafter mentioned is paid. (Ord. 97-2-2: Ord. 96-2-1: § 5(4) of Ord. passed 9/11/72).

**10.28.120 Temporary No Parking Zones.**

A. The Chief of Police is authorized to erect signs indicating temporary no parking upon either or both sides of a street when such parking would, in his opinion, interfere with traffic or create a hazardous situation. Any temporary no parking signs erected for a period of more than fifteen (15) days shall require Village Board approval.

B. When temporary no parking signs are erected by the Chief of Police, no person shall park a vehicle in any such designated place. (Ord. 99-6-3).

**10.28.130 Maximum Parking Time.**

A. Except as provided in subsection B of this Section, no person shall permit any vehicle within his control to be parked in any public roadway or parking lot for more than forty-eight (48) consecutive hours.

B. When signs have been erected at or reasonably near the corporate limits of the Village as provided in Section 349.13, Wisconsin Statutes, no person shall park any vehicle for a period of time longer than thirty (30) minutes between the hours of twelve (12:00) midnight and seven (7:00) a.m. of any day from October 1st to May 1st except physicians on emergency calls on any of the following streets:

(Ord. 99-6-2: § 5(6) of Ord. passed 9/11/72).

**10.28.140 Stopping, Standing Or Parking Of Vehicles On Village Streets And Roadways.**

No person shall park, stop or leave standing any vehicle, whether attended or unattended, upon any street or roadway of any street or highway in the Village unless an unobstructed width of at least fifteen (15) feet upon the roadway of such street or highway is left opposite such standing vehicle for the free passage of other vehicles. This Section shall not apply to busses used exclusively for the transportation of school children when such busses are loading or unloading such children where red flashing signal lights are used as required by law. (Ord. 76-8-1).

**10.28.150 School Bus Operators To Use Flashing Red Warning Lights.**

School bus operators shall actuate flashing red warning lights and extend the stop arm when pupils or other authorized passengers are boarding or alighting from a school bus in the residential or business districts of the Village wherever curbs and sidewalks have been constructed on both sides of the street. (Ord. 87-4-2).

**10.28.160 Parking Of Large Motor Vehicles.**

No person shall park or leave standing any motor vehicle in excess of twenty-three (23) feet in length on any public street, public parking lot or property of the Village at any time except:

A. In commercial and industrially zoned districts where such parking is not otherwise prohibited or restricted, vehicles in excess of twenty-three (23) feet in length may be parked for periods of time not in excess of two (2) hours between the hours of six (6:00) a.m. and three (3:00) p.m.

B. Commercial vehicle in excess of twenty-three (23) feet in length may be parked on any public street in any district (residential, commercial or industrial) for a temporary period of time necessary to make a pickup or delivery from a building fronting on said public street between the hours of six (6:00) a.m. and five (5:00) p.m. provided further that such pickup or delivery shall commence immediately upon parking the vehicle and continue without interruption until completed. (Ord. 89-4-3).

All streets and alleys within the Village, except the following enumerated streets and alleys, are designated class B highways and shall be subject to the weight limitations imposed by Section 348.16, Wisconsin Statutes. (§ 6(1) of Ord. passed 9/11/72).

**10.32.020 Special Or Seasonal Weight Limits.**

The Department of Public Works shall have the authority to impose special or seasonal weight limits to prevent injury to the roadway of any highway, bridge or culvert within the jurisdiction of the Village or for the safety of users of such highway, bridge or culvert and shall be responsible for erecting signs giving notice thereof in accordance with Section 349.16, Wisconsin Statutes. (§ 6(2) of Ord. passed (9/11/72).

**10.32.030 Heavy Traffic.**

A. The following streets and parts of streets within the Village are designated heavy traffic routes:

\_\_\_\_\_ street from \_\_\_\_\_ avenue to \_\_\_\_\_ street.

B. Restrictions on use of Other Streets by Heavy Traffic. No vehicle, except a motor bus, which is not equipped with pneumatic tires or has a combined vehicle load weight exceeding six thousand pounds shall be operated or moved on any street or alley not part of the heavy traffic route designated in subsection A of this Section in the Village, except for the purpose of obtaining orders for, moving or delivering supplies or commodities to or from a place of business or residence facing thereon; provided that in no event shall the weight of vehicle and load on such other street exceed the limitations of Sections 348.15 or 348.16(3) of the Wisconsin Statutes pertaining to Class A highways or deliveries on Class B highways. (§ 6(3) of Ord. passed 9/11/72).

**10.32.040 Lugs Prohibited.**

No tractor having lugs shall be operated upon the streets, roads or alleys of the Village at any time, and any person who violates the same shall be subject to the penalties provided in Section 10.48.010. (Prior Code § 3.09).

A. It shall be contrary to Ordinance and hereafter no car, truck or motor vehicle shall drive on or be permitted on the ice of either Lake Elizabeth or Lake Mary without written permit of the Village Board; except to allow driving and parking of cars by fishermen on the ice between the hours of six (6:00) a.m. and nine (9:00) p.m.

B. Anyone, person, firm or corporation violating this Section shall be subject to penalty as provided in Section 10.48.010. (Ord. 94-3-1; Ord. passed 12/10/62; Ord. passed 4/9/56; prior Code § 10.21).

#### **10.40.010 Riders And Rentals.**

- A. Not more than one person shall ride upon a power bicycle or cycle not designed for carrying passengers.
- B. A rental agency shall not rent or offer to rent any bicycle unless the bicycle is licensed and the license tag is firmly attached as provided herein, and such bicycle is equipped with lamps and other equipment as required in this Chapter. (§ 13 of Ord. passed 9/11/72).

#### **10.40.020 Equipment.**

- A. It is unlawful for any person to propel, ride or operate a bicycle upon the streets or public highways of this Village unless such bicycle shall:
  1. Comply with the requirements of Section 347.489, Wisconsin Statutes, relating to the equipment of bicycles;
  2. Be equipped with a brake in good working condition, adequate to control the movement of and to stop such bicycle whenever necessary;
- B. Equipment Prohibited. It is unlawful to operate any bicycle upon the streets or public highways of this Village when equipped with a siren or whistle. The term "siren" shall mean any instrument which is used for producing sound by means of air being forced over or through any mechanical device. The term "siren" shall also include whistles. (Ord. 2010-4-1; Ord. 96-9-1 § 2 (part); editorially amended per approval by Village Board 7/8/96; § 14(1), (2) of Ord. passed 9/11/72).

#### **10.40.030 Rules for operation.**

It is unlawful for any person to propel, operate or ride upon a bicycle on any street or public highway in this Village except in compliance with the following regulations:

- A. Every bicycle shall be kept as close to the right hand curb as possible.
- B. Right Turns- Every person operating a bicycle intending to turn to the right at an intersection, alley or driveway shall approach the turning point in the line of traffic nearest the right hand curb of the street.

Left Turns- Every person operating a bicycle intending to turn left at an intersection or to enter an alley or driveway shall approach the point of turning in the line of traffic nearest to the center of the roadway and shall pass to the left of center of the intersection before turning.

When giving hand signals, such signals shall be given from the left side of the bicycle in the following manner and shall indicate as follows:

1. Left Turn- Hand and arm extended horizontally.
2. Right Turn- Hand and arm extended upward.
3. Stop or decrease speed- Hand and arm extended downward.
- C. Bicycles shall be operated in single file only except as described herein. Persons riding bicycles upon a roadway may ride two (2) abreast if such operation does not impede the normal and reasonable movement of traffic. Bicycles riding two (2) abreast on a two-lane or more roadway shall ride within a single lane.
- D. No person riding upon a bicycle shall cling or attach himself or his bicycle to any other moving vehicle, streetcar or sleigh. The operator of a bicycle shall not carry another person on such bicycle nor

shall any coaster sled, person on roller skates, toy vehicle, or other similar vehicle, be attached to or towed or drawn by any bicycle. Notwithstanding the forgoing, the operator of a bicycle may tow a person or persons if all of the following conditions exist:

1. The person or persons being towed are secured within a commercially available trailer;
2. The trailer is designed for use as a carrier of persons;
3. The trailer is being used in accordance with the manufacturer's specifications; and,
4. The trailer is equipped with a red reflector that has a diameter of at least two (2") inches of surface area or is a strip of reflective tape that has at least two (2") inches of surface area, on the rear of the trailer so mounted and maintained as to be visible from all distances from fifty (50') feet to five hundred (500') feet to the rear when directly in front of lawful upper beams of headlamps on a motor vehicle.

E. No person operating a bicycle shall participate in any race, speed or endurance contest with any other vehicle or bicycle.

F. No rider of a bicycle, while in motion, shall remove both hands from the handlebars nor his feet from the pedals nor practice any acrobatics or fancy riding. No person operating a bicycle shall carry any package, bundle or article which prevents the safe operation of the bicycle with at least one (1) hand on the handlebars at all times.

G. Every person operating a bicycle shall stop for all arterial highway signs and all traffic signals.

H. Every person operating a bicycle upon a sidewalk or walkway, shall yield the right-of-way to any pedestrian and shall exercise due care and give an audible signal when passing a bicycle rider or pedestrian proceeding in the same direction except that operation of a bicycle shall be prohibited on sidewalks or walkways in the downtown business district on East Main Street between Burlington Avenue and North Lake Avenue, on North Lake Avenue from East Main Street to East Hunt Avenue and on all of South Lake Avenue. (Ord. 2010-12-4)

I. No bicycle shall be placed unattended:

1. In any roadway unless it is standing erect at the established curb line or outside of the portion of the roadway commonly used for vehicular traffic; or

2. In any alley unless it is standing erect at the extreme outer edge of such alley against a building or other immovable object; or

3. Upon the traveled portion of any sidewalk unless it is standing erect against a building or other immovable object upon the traveled portion of such sidewalk. The word "sidewalk" as used in this paragraph shall, in addition to the portion of the highway defined in Section 340.01 (58), Wisconsin Statutes, include any space between the lot line and the building line which is improved as a sidewalk and ordinarily used for public travel.

J. Every rider of a bicycle shall upon entering a public highway yield the right-of-way to motor vehicles.

K. No person may operate a bicycle upon any Village street, alley, highway or public thoroughfare during the hours of darkness unless such bicycle is equipped with or the operator is wearing a lamp omitting a white light visible from a distance of at least five hundred (500') feet to the front of the bicycle. Such bicycle shall also be equipped with a red reflector or light that has a diameter of at least two (2") inches of surface area mounted and maintained so as to be visible to the rear thereof.

L. Child Carriers: The operator of a bicycle may attach and utilize no more than one (1) child carrier, as herein defined, to a bicycle, for each set of handlebars, for the purpose of carrying a child, provided that:

1. The operator is fourteen (14) years of age or older.
2. The child using the carrier is under the age of six (6) years.
3. The child carrier is securely fastened to the bicycle and located behind the front handlebar. The use of a child carrier contrary hereto is prohibited. The term "child carrier" shall mean a seat manufactured and designed expressly to be attached to a bicycle and equipped with a belt to restrain a child in the seat, two (2) arm rests, a back rest, foot rest and spoke protection and is for use by children under the age of six (6) years.

M. No person may operate a bicycle upon a highway while such operator is using any audio device attached directly to their ear or ears of such operator that materially impairs the ability of such operator to hear audio signals or warnings.

N. Penalty: Any person who shall violate any provision of this Section shall upon conviction thereof be punished by a fine of not less than ten dollars (\$10.00) and not more than one-hundred dollars (\$100.00), together with costs and disbursements.

The first time a child is detained by a law enforcement Officer for violation of any of the provisions of this Section, his/her parent, guardian or person having such legal custody may be advised as to the provisions of this Section and further advised that any violation of this Section occurring thereafter by this child or any other child under his/her care or custody may result in a penalty being imposed, in accordance with Chapter 9.78 of this Code.

#### **10.44.010 General Provisions.**

A. State Snowmobile Laws Adopted. Except as otherwise specifically provided in this Chapter, the statutory provisions describing and defining regulations with respect to snowmobiles in the following enumerated Sections of the Wisconsin Statutes are adopted by reference and made part of this Chapter as if fully set forth herein. Acts required to be performed or prohibited by such statutes are required or prohibited by this Chapter.

- 350.01 Definitions
- 350.02 Operation of snowmobiles on or in the vicinity of a highway
- 350.03 Right-of-way
- 350.04 Snowmobile races, derbies and routes

- 350.055 Safety certification program established
- 350.07 Driving animals
- 350.08 Owner permitting operation
- 350.09 Head lamps, tail lamps and brakes

- 350.15 Accidents and accident reports
- 350.17 Enforcement

B. Applicability of Rules of the Road to Snowmobiles. The adoption of Section 346.02(10) of the Wisconsin Statutes by reference is intended to include the rules of the road therein enumerated which are as follows: 346.04, 346.06, 346.11, 346.14(1), 346.18 to 346.21, 346.26, 346.27, 346.33, 346.35, 346.37, 346.39, 346.40, 346.44, 346.46 to 346.48, 346.50(1) (b), 346.51 to 346.55, 346.87 to 346.91, 346.92(1) and 346.94(1) and (9).

C. Permitting Operation by Improper Persons Prohibited. No owner or other person having charge or control of a snowmobile shall authorize or permit any person to operate such snowmobile who is not permitted under State law to operate such snowmobile or is under the influence of an intoxicant or a dangerous or narcotic drug.

D. Operation While Under the Influence Prohibited. Sections 346.63 and 350.101, Wisconsin Statutes, shall apply to the operation of snowmobiles. (Ord. 2000-2-3: Editorially amended per approval by Village Board 7/8/96; § 1 of Ord. passed 1/8/73).

#### **10.44.020 Routes And Trails.**

A. Except as provided in Sections 350.02 and 350.045 of the Wisconsin Statutes, or for snowmobile events authorized in accordance with Section 350.04, Wisconsin Statutes, no person shall operate a snowmobile upon any public right-of-way, in any public park, golf course or on any other public municipal property in the Village, except upon the following designated snowmobile routes and trails.

Routes and Trails. The following streets or portions thereof are designated snowmobile routes and trails:

1. Park Avenue from Highway Z to West Main Street;
2. West Main Street west from Burlington Avenue west to the 400th block of West Main Street;
3. Musial Road from Spiegelhoff Road to Lake Elizabeth;
4. Former Chicago and Northwestern Railroad right-of-way from the eastern limits of the Village to the old Chamber of Commerce building location;
5. Barry Road to Wilmot Avenue; Wilmot Avenue to Rink Avenue; Rink Avenue to Chapel Avenue;
6. South side of Lance Drive from the entrance to Lance Park westward for a distance of one-half (1/2) mile, including parkways;
7. Spiegelhoff Road from Highway P to Musial Road;
8. Village Road property between 847 Legion Drive and 901/903 Legion Drive and north across Legion Drive;
9. Paved portion of Lance Park; and
10. A route parallel to and adjacent to the East side of Legion Park.

B. The Department of Public Works is directed and authorized to procure, erect and maintain appropriate snowmobile route, trail and limit signs and markers as approved by the State of Wisconsin Department of Natural Resources under Section 350.13, Wisconsin Statutes.

C. No person shall fail to obey any route or trail sign, marker or limit erected in accordance with this Chapter.

D. No person shall operate a snowmobile on a roadway or shoulder of a highway not designated as a snowmobile route under subsection A of this Section; except all persons shall be allowed to operate a snowmobile for the purpose of residential or lodging access in all sections of the Village, except those listed below in this subsection, provided that they shall travel with traffic on the extreme right side of the paved portion of the roadway at speeds not in excess of those defined in Section 10.44.030 of this Code and provided that they travel the shortest distance to or from the snowmobile trail or route that is closest to the residence or lodging establishment and subject to all other provisions of the Village Ordinance and state law.

Notwithstanding designated routes and trails, snowmobiles shall not be operated within the right-of-way of any county trunk highway except as provided in Sections 350.02 of the Wisconsin Statutes.

#### **10.44.030 Additional Regulations.**

A. Speed. No person shall operate a snowmobile upon a public highway within the Village at a speed in excess of ten (10) miles per hour during the hours between ten-thirty p.m.(10:30) and seven a.m. (7:00) or in excess of fifteen (15) miles per hour at other times.

B. Unattended Snowmobiles. No person shall leave or allow a snowmobile to remain unattended on any public highway or public property while the motor is running or with the starting key in the ignition.

C. Operation on Sidewalks and Malls Prohibited. No person shall operate a snowmobile on any sidewalk, pedestrian way or mall within the Village except as specifically authorized by Section 10.44.020 or for the purpose of crossing to obtain immediate access to an authorized area of operation. (§ 3 of Ord. passed 1/8/73).

**10.44.040 Enforcement.**

A. Uniform Citation for Highway Violations. The uniform traffic Citation promulgated under Section 345.11, Wisconsin Statutes, shall be used for violations of this Chapter relating to highway use except as herein provided.

B. Parking Violations. The special traffic Citation described in subsection A above shall be used for enforcement of violations or rules of the road relating to parking of vehicles adopted by reference in Section 10.44.010(B).

C. Other Violations. All violations of this Chapter not described in subsection A or B above, shall be enforced in accordance with Sections 66.12 and 66.114 and Chapters 345 and 755 of the Wisconsin Statutes. Stipulations of guilt or no contest may be made as provided in Section 66.12(1)(b), Wisconsin Statutes, in substantially the form provided in the uniform traffic Citation within five (5) days of the date of the Citation for such violation. Bail deposits may also be made under Section 66.12, Wisconsin Statutes. Such deposits shall include statutory costs and penalty assessments.

D. Police Department to Receive Stipulations and Penalties. Stipulations, forfeited penalties and deposits for obtaining release from arrest authorized under this Chapter may be accepted at the Village Police Department Offices by the Chief or Officer designated by him. The Officer authorized to accept penalties and deposits shall be bonded and such bond shall be filed with the Village Clerk/Treasurer.

E. Forfeited Penalties and Deposits. Except as otherwise provided in Section 345.26, Wisconsin Statutes, the Uniform Wisconsin Statutes Schedule for Cash Deposits for Conservation, Boating or Snowmobile Offenses shall be the deposit schedule for violations of this Chapter. For violations of this Chapter not covered by said Uniform Wisconsin Schedule, the deposits shall be fifty dollars (\$50.00) plus costs and penalty assessment.(Editorially amended per approval by Village Board 7/8/96;Ord. 78-12-1:§5 of Ord. passed 1/8/73).

**10.44.050 Penalty For Violations.**

Any person who violates any provision of this Chapter shall upon conviction thereof be subject to penalty as provided in Section 10.48.010; provided no person shall forfeit an amount in excess of the maximum fine or forfeiture allowed in the Wisconsin Statutes for the same offense and further provided that the penalty and forfeiture for parking violations on highways shall be the amount applicable to such violations by owners or operators of motor vehicles under Section 10.44.040. (§ 5 of Ord. passed 1/8/73).

**10.44.051 All-Terrain Vehicles.**

(a) General Penalties. Any person who violates any Section of this Ordinance wherein a forfeiture is not specifically enumerated shall forfeit not more than two hundred fifty dollars (\$250.00) together with costs of prosecution.

(b) Any person who shall be convicted of operating an all-terrain vehicle (first offense) under Section (4c)(a) 1 or 2 or (4p)(e) shall forfeit not less than one hundred fifty dollars (\$150.00) nor more than three hundred dollars (\$300.00) together with costs of prosecution.

(c) Any person who violates Section (4c)(a) 3 and (4P)(e) and has not attained the age of nineteen (19) years shall forfeit not more than fifty dollars (\$50.00) together with costs of prosecution.

(d) Sections 23.33 (13)(dm) and (e) Reporting convictions to the department and Alcohol or controlled substances assessment are herewith adopted.

C. No person shall operate an all-terrain vehicle on a roadway or shoulder of a highway not designated as an all-terrain vehicle route.(Ord. 2010-12-3 § 3); (Ord. 2005-9-1; Ord. 90-2-2).

**10.48.010 Penalties.**

The penalty for violation of any provision of this Title shall be a forfeiture as hereinafter provided together with the cost of prosecution imposed as provided in Sections 345.20 to 345.53, Wisconsin Statutes.

A. Uniform Offenses. Forfeitures for violation of any provisions of Chapters 341 to 348 adopted by reference in Section 10.04.020 shall conform to forfeitures for violation of the comparable state offense, including any variations or increases for second offenses.

B. Special Local Forfeiture Regulations.

1. The forfeiture for violating the following Sections of this Chapter shall be not less than twenty-five dollars (\$25.00) or more than two hundred dollars (\$200.00) for the first offense, and not less than fifty dollars (\$50.00) nor more than five hundred dollars (\$500.00) for the second offense within one (1) year:

- a. Section 10.12.010, accident reports;
- b. Section 10.24.020, one-way streets;
- c. Section 10.34.010, driving on ice;
- d. Section 10.36.040, abandoned automobiles;
- e. Section 10.32.010, weight limits;
- f. Section 10.32.040, lugs prohibited.

2. Forfeiture for violations of Sections 10.44.010 to 10.44.030 (snowmobiles) shall be as provided in Section 10.44.040.

3. The forfeiture for violating provisions of subsection B of Section 10.44.020 shall be not less than twenty-five dollars (\$25.00) nor more than two hundred dollars (\$200.00).

4. Non-Moving Traffic Violations.

b. Parking in the prohibited areas as set forth in Sections 10.28.031, 10.28.035 and 10.28.040 shall carry a forfeiture of not less than fifty dollars (\$50.00) nor more than one hundred dollars (\$100.00).

c. For all violations of Chapter 10.28, any person who desires to deny guilt may deliver a not guilty plea to the Police Department within forty-eight (48) hours after the date and time indicated on the violation notice and the matter will be transferred to the Municipal Court for a court hearing.

d. Any vehicle parked in violation of Chapter 10.28 may be towed at the direction of the Chief of Police, or their respective designees. The owner of a towed vehicle shall be responsible for all towing and storage charges in addition to any forfeitures.

e. In the case of unpaid forfeitures under this Section, the provisions of Section 345.28 of the Wisconsin Statutes is adopted as means to assure compliance with this Chapter.

5. Presumption of Ownership. The person to whom the vehicle is registered on the date of the parking Ordinance violation shall be the party charged with the violation, and the registered owner shall be presumed to be the property party, always provided that the presumption may be overcome by submitting proof that the vehicle was stolen at the time of the violation and was reported to law enforcement authorities as stolen before the Citation was issued, or that the vehicle was legally parked and there was no violation.

C. Miscellaneous. The forfeiture for violation of any provision of Section 10.04.020(B) shall be not less than fifty dollars (\$50.00) nor more than five hundred dollars (\$500.00). (Ord. 2010-9-2 (4a); Ord. 99-6-4 § 2; Ord. 85-10-1 § 6 (part); § 10 of Ord. passed 9/11/72).

\* Minimum forfeitures may be amended to correspond to deposit schedule fixed by Board of County Judges.

**10.48.020 Denial Of Registration For Nonpayment.**

A. Intent. The intent of this Section is to implement the procedures of Sections 345.28 and 345.47, Wisconsin Statutes, to request the Department of Transportation, Motor Vehicle Department, to suspend or non-renew vehicle registrations for nonpayment of forfeitures.

B. Definitions. As used in this Section:

1. "Clerk" means the Clerk of the of the Municipal Court of the Village of Twin Lakes.
2. "Court" means the Municipal Court of the Village of Twin Lakes.
3. "Forfeiture" means and includes any fine established for violation of the nonmoving vehicle Code of the Village of Twin Lakes.
4. "Nonmoving traffic violations" means any violation of parking regulations of the Twin Lakes Traffic Code.
5. "Judgment" means any finding or judgment of the Municipal Court of the Village of Twin Lakes.

C. Clerk to Notify Motor Vehicle Department.

1. Any person who shall be charged with a nonmoving traffic violation and has not paid the stipulated fine, or has failed to appear in Municipal Court as provided in the Citation, or on any date for which the appearance is continued, or within twenty-eight (28) days after the Citation is issued if no court date is specified, the court may issue a summons requiring the person to appear, or may in lieu thereof, or in addition thereto, notify the Motor Vehicle Department of the nonappearance and nonpayment of forfeiture.

2. The Clerk shall request the Motor Vehicle Department to suspend registration of the motor vehicle involved in said Citation, or refuse registration of any vehicle owned by the person cited for such nonmoving violation, or both, upon the direction of the Court.

3. \*a.\*Prior to notifying the Motor Vehicle Department of nonpayment of fine or forfeiture, the Clerk shall mail a notice to the person on two (2) separate days at least one (1) week apart to the last known address of the person to whom the Citation was issued, which notice shall include the date the Citation was issued, the license number of the vehicle involved, the place the Citation may be paid, means by which the Citation may be contested, and the date by which the person must pay or contest the Citation to avoid further action. The notice shall also inform the person of the fact that failure to appear or to pay the forfeiture may result in a warrant being issued or Motor Vehicle Department being notified and a request made to suspend the registration or refuse to register any vehicle owned by the person cited.

b. In the event that the court shall issue a warrant for nonappearance or nonpayment of a nonmoving violation, the procedure set forth in Section 345.28(5), Wisconsin Statutes, shall apply.

D. Judgments. In the event that the person cited shall subsequently pay the amount of the forfeiture or judgment and the costs, or shall appear in court in response to the Citation or notices by the Clerk, the Clerk shall immediately notify the Motor Vehicle Department of said payment.

E. Failure to Pay Judgment of Forfeiture and Penalty Assessment. In addition to or in lieu of confinement to the County Jail, or for the suspension of license as provided in 345.47, Wisconsin Statutes, the court may notify the Department of Motor Vehicles that a judgment has been entered against the defendant and remains unpaid. The court shall further certify to the Department of Motor Vehicles that a warrant has been served on the person against whom the judgment was entered or, in case of a judgment entered for non-moving violation, that the person has been notified of the entry of judgment, that the entry of judgment remains unpaid, and the place where the judgment may be paid.

F. Forms and Costs. The Clerk and the court shall provide such information and on such forms and in such manner as prescribed by the Department of Motor Vehicles. Any costs which may be assessed by the Department of Motor Vehicles shall be paid by the Village, and shall be added to the forfeiture, penalty assessment and costs as determined by the court. (Ord. 85-10-1 § 6 (part)).

#### **10.48.030 Nonmoving Violation And Registration Program.**

Pursuant to the provision of Section 345.28(4) of the Wisconsin Statutes, the Village elects to participate in the nonmoving traffic violation and registration program of the Wisconsin Department of Transportation and pay the costs established by the Department under Section 85.13 of the Wisconsin Statutes; such costs shall, in turn, be assessed against persons charged with nonmoving traffic violations. (Ord. 99-6-5)
