A RESOLUTION REQUESTING EXEMPTION FROM THE COUNTY LIBRARY TAX FOR 2020 BUDGET FOR THE VILLAGE OF TWIN LAKES

WHEREAS, the Kenosha County Board levies a county library tax as authorized under Section 43.64(1) of the Wisconsin Statutes, and

WHEREAS, Section 43.64(2)(b) of the Wisconsin Statutes provides that a municipality may exempt itself from the county library tax by levying a tax for public library service and appropriating and expending for a library fund as defined by Section 43.52(1) of the Wisconsin Statutes an amount during 2020 at least equal to the county tax rate in 2019 multiplied by the 2019 equalized valuation of property in the municipality, as determined on or about August 30, 2019, and

WHEREAS, the Village of Twin Lakes will appropriate in 2019 and expend in 2020 an amount at least equal to \$269,823, which is the amount necessary to exempt all properties in the Village of Twin Lakes from the county library tax as calculated above,

NOW THEREFORE BE IT RESOLVED, that the Village of Twin Lakes hereby requests Kenosha County Board of Supervisors that all properties in the Village of Twin Lakes be exempted from the payment of the county library tax in 2020 as provided in Section 43.64(2).
