PROCLAMATION RECOGNIZING SERGEANT ROBERT J. DZBINSKI FOR 28 YEARS OF EXCELLENCE IN SERVICE TO THE VILLAGE OF TWIN LAKES

PRESIDENT AND TRUSTEE REPORTS

TRUSTEE SHARON BOWER - ADMINISTRATION, FINANCE, JUDICIARY, LICENSING

Consideration of a motion to approve Resolution 2021-01-01 Authorizing the Issuance and Sale of \$1,315,000 General Obligation Refunding Bonds, Series 2021A

Jonathan Schatz from Ehlers stated 4 bids were taken today at 11:00 am for the sale. We received great rates, which was a lot less than Ehlers predicted. The winning bid was from Bankers Bank of Madison with a true interest rate of 1.0942%. The highest interest rate bid was 1.3476%. Because of the interest savings, we were able to downsize the borrowing from \$1,315,000 to \$1,275,000. This is a \$70,000 savings over the life of the debt. A revised resolution was presented to the board with the updated sale amount of \$1,275,000 GO Refunding Bonds.

Motion by Karow/Fitzgerald to approve Resolution 2021-01-01 Authorizing the Issuance and Sale of \$1,315,000 General Obligation Refunding Bonds, Series 2021A. Motion carried 4 to 0.

Payment of Taxes on Village Parcels Purchased in 2020

- Village Hall Land (85-4-119-214-2435)
- **349 E Main Street 3 lots (85-4-119-211-4420, 4431, 3624)**

These parcels were purchased in 2020. As of January 1, 2020 they were not tax exempt; therefore, the Village owes the taxes due on these parcels. The assessor has been notified to change the status to tax exempt.

Motion by Karow/Andres to approve payment of taxes on Village parcels. Motion carried 4 to 0.

Routes to Recovery Grant Reimbursement Update

This program is federally funded through the CARES Act Coronavirus Relief Fund, which allows reimbursement for necessary, unbudgeted expenditures incurred due to the COVID-19 public health emergency. The Village received reimbursement totaling \$110,434.02.
