RESOLUTION NO. 2020-07-01

A RESOLUTION COMMITTING TO INCREASE SEWER SERVICE RATES IN CONJUNCTION WITH THE REQUIREMENTS OF A CLEAN WATER FUND LOAN

WHEREAS, the Village is in the process of obtaining a Clean Water Fund loan from the State of Wisconsin in order to finance necessary treatment plant upgrades; and,

WHEREAS, in conjunction with that loan, the State has indicated that certain increases must be made to the Village's sewer rate structure in order to maintain the proportionality among user classes of the service charge system, and to ensure that adequate revenues are available for debt service costs.

NOW, THEREFORE, BE IT RESOLVED: That the Village Board will, at the end of 2021, effective the beginning of 2022, eliminate the current \$24 annual discount for customers who pay their annual sewer charge by the due date of their first quarterly installment; and,

BE IT FURTHER RESOLVED: That the Village Board will, at the end of 2021, effective the beginning of 2022, adopt an ordinance to increase the Village's volume charge rate to \$115 per quarter; and,

BE IT FURTHER RESOLVED: That the Village Board will, at the end of 2022, effective the beginning of 2023, adopt an ordinance to increase the Village's volume charge rate to \$120 per quarter.
