### A RESOLUTION TO APPROVE THE JURISDICTIONAL TRANSFER OF A SECTION OF 89<sup>TH</sup> STREET (FORMER CTH F) TO THE VILLAGE OF TWIN LAKES


WHEREAS, Kenosha County and the Village of Twin Lakes in the State of Wisconsin have determined it to be mutually beneficial to jurisdictionally transfer a section of 89<sup>th</sup> Street (former CTH F) as outlined on Exhibit A, totaling .25 miles, and

WHEREAS, this jurisdictional transfer is described in the Intergovernmental Agreement approved by both Kenosha County and the Village of Twin Lakes in 2020, and

WHEREAS, Section 83.025, Wisconsin Statutes, enables Kenosha County to enter into jurisdictional transfer agreements with the Village of Twin Lakes, thereby facilitating alterations in jurisdictional highway systems.

**Letter Modifying the Terms of the Intergovernmental Agreement (IGA) on Jurisdictional Transfer of Roadways and Alteration of Municipal Boundaries By County of Kenosha, Wisconsin, Town of Randall, Wisconsin, and Village of Twin Lakes, Wisconsin, For Part of County Trunk Highway "F"**

All,

Now that all construction is complete for the "CTH F Realignment Project" and the IGA defined infrastructure improvements, the County recently contacted Andrew Levy of the Wisconsin Department of Transportation (DOT) to begin the Jurisdictional Transfer (JT) process. In our conversation with Andrew, we learned the following:

- **Resolution** – The DOT's JT process will require the Village, Town and County to develop and pass resolutions defining and agreeing to the specific road sections being transferred.
- **No Need for Boundary Modifications** – There is no DOT requirement for any municipal boundary changes between the Village and Town to secure JT approval for the defined sections of former CTH F (890<sup>th</sup> Street).

We will begin drafting resolutions that the County, Village and Town Boards can all consider that will meet the DOT's requirements for JT.


Regarding the new information that no municipal boundary modifications will be required, we felt it important to record this change and note its impact on the IGA signed in 2020. Please consider the following a memorialization of this:

1. During the course of 2020, the County of Kenosha ("County"), the Town of Randall ("Town"), and the Village of Twin Lakes ("Village"), collectively referred to as the "Parties," negotiated and entered into an Intergovernmental Agreement ("IGA") related to the jurisdictional transfer of a part of County Trunk Highway "F."


2. As a part of that IGA, it was believed that the municipal boundaries between the Town and the Village were required to be modified in order to ensure approval, by the State of Wisconsin, of the jurisdictional transfer, as it was believed such transfers could only occur when the roadway being transferred was located entirely and wholly within one municipality.
3. Since the time the IGA was entered into, the State of Wisconsin, through the Department of Transportation, has advised that no such requirement exists, negating any need for the Town and Village to in any way modify their municipal boundaries.
4. Accordingly, and without making any other changes to the agreement as previously entered into, by their signature on this letter the Parties agree that any conditions within the IGA requiring a change in the municipal boundaries of the Town or Village, including II. B. 3 and II C. 3 are hereby rescinded and that none of the parties shall attempt to enforce the same against any other party.
5. All other terms and conditions of the IGA shall remain in full force and effect including, but not limited to, Section III in which the Town and Village may choose to enter into a maintenance agreement, separate from the terms of the IGA.
6. The Parties acknowledge their understanding and acceptance of everything stated in this letter, including reiterating their obligations as set forth in the IGA and not otherwise modified herein.
