TRUSTEE KEVIN FITZGERALD - STREETS & ROADS, EQUIPMENT, STREET LIGHTS, WEEDS, LAKE PLANNING AND PROTECTION

Discussion regarding a request from Oak Meadow Subdivision to extend their sidewalk installation deadline. Village Engineer Greg Droessler supports the extension. This is a change as in the past, once a specified amount of time had passed the village would install the sidewalks and special assess the property owner. Village holds a valid letter of credit.

Discussion regarding the 2022 road project.

Presented roads for approval by the board. Storm sewer work will be partially funded by the Lake District. Trustee Kaskin requested adding Esch Road and Willow Road. PASER Road Rating System was used and we have many low category roads. Estimates for these changes will be brought to the board meeting.

Discussion regarding amending section 10.28 of the Village Code Pertaining to Stop Streets and Parking Limitations.

Ordinance adds signs both east and west on Esch Road at the intersection of Elizabeth Lane. Requested by residents.

TRUSTEE AARON KAROW - BUILDING AND ZONING, PLAN COMMISSION, AND PUBLIC BUILDINGS

Consideration of a motion to approve Ordinance 2021-11-1 Pertaining to Swimming Pools.

Approved by Village Attorney. This allows pools on the lake side of the house as long as it meets required setbacks. Previous ordinance said pools weren't allowed in front yards. For houses on the lake, the front yard is considered the lake side.

TRUSTEE JEREMY KNOLL - POLICE, FIRE, LAKE CONTROL, PARKS AND BEACHES

Discussion regarding a request from the Aquanuts to extend their concession stand lease with the Village.

Same lease as last year. Aquanuts would be happy to do a 2-year lease if the board would like.
