We have received a request to reduce the retainage. If this amount is released there will only be \$29,000 remaining to pay. Board felt payment should be held off until there is a resolution on the siding and credit pertaining to the ceiling change in the office space. Discussion and possible action regarding Asbestos Abatement for 108 E. Main Street.

Received quotes from Balestrieri and DJK Environmental. Costs were similar but hard to compare as DJK had an alternate bid with additional items. Timeline of work is important. Board would like to give the Administrator the ability to choose the company based on the earliest committed date and also provide her the authority to approve additional costs that may arise during the abatement.

Skinner/Fitzgerald motion to approve the asbestos abatement up to \$16,000 taking the best bid with the fastest time. Motion carried unanimously.
