#### **MINUTES**

#### Call to Order

Clerk Waswo called the meeting to order at 10:01 a.m.

#### **Selection of Chairperson**

<u>Infusino/Pawasarat motion to nominate Tim Infusino as Chairperson for the 2022 Board of Review. Motion</u> carried 4-0.

The 2022 Board of Review meeting was turned over to Chairperson Tim Infusino.

# Verification that at least one member has met the mandatory training requirements specified in Wis. Stats. § 70.46 (4)

Clerk Waswo stated Tim Infusino and Jim Hayes took the training in June and the certification has been filed with the WI Department of Revenue.

# Verification the Village ordinance for confidentiality of income and expense information has been provided to the Assessor

The ordinance was provided by email to Accurate Appraisal.

Announcement that Notices of Assessments were mailed and Open Book session was held on May 18, 2022. Confirmed by Assessor Belcher.

### Summary of Annual Assessment Report by Assessor's Office

Assessor Belcher from Accurate Appraisal reported 2022 was a maintenance year. Twin Lakes had new construction valued at \$17,138,600. Property physically destroyed or removed from the assessment roll was valued at \$332,900.

Clerk Waswo received the assessment roll and assessor's affidavit from the assessor.

Verification from Assessor that all Open Book changes have been included in the assessment roll Confirmed by Assessor Belcher.
