NOTICE OF LIEN RIGHTS

AS REQUIRED BY THE WISCONSIN CONSTRUCTION LIEN LAWS, CONTRACTOR HEREBY NOTIFIES OWNER THAT PERSONS OR COMPANIES FURNISHING LABOR OR MATERIALS FOR THE CONSTRUCTION ON OWNER'S LAND MAY HAVE LIEN RIGHTS ON OWNER'S LAND AND BUILDING IF NOT PAID. THOSE ENTITLED TO LIEN RIGHTS, IN ADDITION TO THE UNDERSIGNED CONTRACTOR, ARE THOSE WHO CONTRACT DIRECTLY WITH THE OWNER OR THOSE WHO GIVE THE OWNER NOTICE WITHIN SIXTY (60) DAYS AFTER THEY FIRST FURNISH LABOR OR MATERIALS FOR THE CONSTRUCTION. ACCORDINGLY, OWNER PROBABLY WILL RECEIVE NOTICES FROM THOSE WHO FURNISH LABOR OR MATERIALS FOR THE CONSTRUCTION, AND SHOULD GIVE A COPY OF EACH NOTICE RECEIVED TO THE MORTGAGE LENDER, IF ANY. CONTRACTOR AGREES TO COOPERATE WITH THE OWNER AND THE OWNER'S LENDER, IF ANY, TO SEE THAT ALL POTENTIAL LIEN CLAIMS ARE DULY PAID.

ACCEPTANCE OF WORK

All labor and material is conclusively accepted as satisfactory unless excepted to in writing within seven (7) days of performance.

EXTRA WORK

All alterations or deviations from any of the terms of this contract shall be in writing and executed by the parties hereto. Any extra cost involved therein will become an extra charge to be paid by PURCHASER over and above the contract price.

PURCHASER'S RESPONSIBILITIES

PURCHASER acknowledges and understands that it shall be responsible for obtaining any and all permits which may be required in connection with performance of this Proposal/Contract. Where applicable, PURCHASER shall also be responsible for backfilling areas that border along the newly paved surface with appropriate material to eliminate potential cracking and uneven surface at the edge of the paved surface and for installing, replacing, maintaining and repairing shoulders. PURCHASER assumes all liability for any damages done to underground utilities and/or structures unless CONTRACTOR has been notified, upon acceptance of this Proposal, as to the specific location and depth of any such buried utility/structures.

Unless exempt, in accepting this Proposal/Contract, PURCHASER acknowledges that it shall comply with the requirements of all applicable federal, state, and local employment laws, executive orders, codes and regulations (the "Requirements") effective where the work and/or services are being performed including, but not limited to, 41 CFR §§ 60-1.4(a)(1)-(8), 60-1.4(b), 60-1.4(b), 60-1.4(b) or their successors effective where this Proposal/Contract is performed. To the extent required by law, all provisions of the Requirements are hereby incorporated into and made a part of this Agreement and any applicable agreements of CONTRACTOR. To the extent applicable, the Requirements include, but are not limited to, (1) prohibition of discrimination because of protected veteran status, disability, race, color, religion, sex, sexual orientation, gender identity, national origin and because of inquiry or discussion about or disclosure of compensation, (2) affirmative action to employ and advance in employment individuals without regard to race, sex, disability, or protected veteran status, (3) compliance with the Employee Notice clause contained in 29 C.F.R. part 471, Appendix A to Subpart A, or its successors, (4) compliance with the EEO-1 and VETS-4212 reports filing requirements in 41 C.F.R. §§ 60-1.7 and 41 C.F.R. § 61-300.10, or their successors, (5) compliance with paycheck transparency obligations of 48 C.F.R. § 22.2005, including the contract clause found at 48 C.F.R. § 52.222-60, which is incorporated by reference as if fully set forth herein, (6) other affirmative action in employment, (7) required/certified payrolls, (8) social security acts, (9) unemployment compensation acts, (10) worker's compensation acts, (11) equal employment opportunity acts and (12) the required contract provisions for Federal-Aid Construction Contracts, Form FHWA-1273, if applicable.

When applicable, PURCHASER and CONTRACTOR shall abide by the requirements of 41 CFR 60-300.5(a). This regulation prohibits discrimination against qualified protected veterans, and requires affirmative action by covered prime contractors and subcontractors to employ and advance in employment qualified protected veterans. INCLEMENT WEATHER

Inclement weather may alter the completion of the work to be furnished hereunder. Furthermore, special consideration should be given if work is to be performed before May 1 or after October 15 in light of less than desirable weather conditions which could potentially impair the quality of the work performed hereunder.

WARRANTY

All material is guaranteed to be as specified and all work is to be completed in a workmanlike manner according to standard practices. All labor and materials will be guaranteed against defect for one (1) year from date of installation. Due to Wisconsin winters and expansion and contraction of the ground, some cracking of the pavement may be experienced. There are no express or implied warranties of merchantability, quality, quantity or of fitness for any particular purpose, which extend beyond those specifically set out in this document.

All warranties are void if payment is not made as stipulated.

DELINQUENCY CHARGE

Payment is due and payable upon completion of each stage of the work. If PURCHASER defaults on the payment required, PURCHASER will be liable for all costs of collection, including reasonable attorney's fees, and a delinquency charge on the balance at the maximum rates allowed by law. If PURCHASER is an organization as defined by Wis. Statutes, Section 421.301(28), the Delinquency Charge rate shall be 1.5% per month (18% APR) plus all costs of collection, including reasonable attorney's fees. CONTRACTOR retains title to all merchandise covered by this Agreement until full payment is received according to the above terms of sale. PURCHASER consents in any action or legal proceeding relating to this Contract commenced by the CONTRACTOR to the personal jurisdiction of any court that is either a court of record in the State of Wisconsin. It is hereby agreed that no legal action with respect to this contract may be brought by either party later than one (1) year after the cause of action accrues and that the party asserting such a legal action shall be barred from any remedy thereto.

INDIVIDUAL LIABILITY

The undersigned PURCHASER agrees to be individually liable for all terms of the Agreement, regardless of whether he or she signs individually or as an agent for the owner of the property upon which the work is being performed or for any other individual, partnership or corporation.

PRODUCT INFORMATION AND MAINTENANCE

Since the asphalt in blacktop needs time to harden and cure, usually 6-12 months, your asphalt pavement will remain soft and pliable during warm weather. During this time, don't park in the same spot every time and do not turn your steering wheel back and forth when your car is not moving. It is not unusual to experience some cracking over the winter due to the contraction and expansion of the ground, especially over culverts, pipes, electric wires, etc. Avoid gasoline and petroleum product spills as they will destroy your pavement. If spills do occur, immediately flush with lots of soapy water. If you decide to seal coat your pavement, wait until the summer following installation.

BINDING EFFECT

This Agreement shall be binding upon the parties hereto, their heirs, personal representatives, successors and assigns.

ENTIRE AGREEMENT

The entire contract is embodied in this writing. This writing constitutes the final expression of the party's agreement, and is a complete and exclusive statement of that agreement. In the event that any term of this contract is unenforceable, the remaining terms of the contract shall still be in full force and effect.

Introduction:

The DNR is looking to reduce the volume of chlorides that enter our lakes and streams in conjunction with the US Environmental Protection Agency. The primary approach to this is to reduce the amount of salt (and chlorides) applied to the roads for snow and ice removal, as well as to reduce the chlorides released to the environment as part of stormwater and wastewater discharge. In the Village of Twin Lakes, the largest contributors of chlorides to our lakes are likely the road salt used during the winter months to make our roads safer, and the use of water softeners in nearly all the residences and businesses in our Village for water treatment. This water softener brine is discharged to the sanitary sewers for treatment, but ultimately is released to the creek (Bassett Creek) as part of the wastewater discharge.

Public Works:

The Public Works department operates under a Municipal Separate Storm Sewer System (MS4) permit issued by the state of Wisconsin that regulates the water quality discharged via the Village's storm sewer system. As part of this permit, the following action is required.

- MS4 permit: The permit requires provisions to reduce the amount of salt used on the roads. The basic steps for public works include:
 - Calibration of the salt spreading equipment (annual)
 - Training of the staff to efficiently operate the equipment (annual)
 - Develop a target application rate for pounds of salt per lane mile.
- Proposed Action Items: The following action items are proposed.
 - Work with the County staff towards a joint training program for salt spreading equipment calibration. Due to the miles of County roads in the Village, we need the County to work with us on calibration of equipment and training of staff.
 - Consider changes to the Village's salting program to potentially reduce the amount of salt that is used. This could include:
 - Less salt in sunny slope areas of the Village.
 - Combining salt/sand to reduce the salt use.
 - Not applying salt after certain low-snow events.

Sewer Department:

The Sewer Department and wastewater treatment facility operates under a Wisconsin Pollutant Discharge Elimination System (WPDES) permit that regulates all components being discharged at the facility, including the chlorides. The WWTF has operated with a Chlorides Variance for the past 10 years, but tighter regulation by both the EPA and Wisconsin DNR requires that the Village make significant strides in reducing the chlorides discharged by the facility.

Greg Richter has worked to develop an updated Chloride Source Reduction Measures (SRM) plan for 2023-2028 for approval by the Wisconsin DNR. A copy of this report is attached.

The Village is tasked with taking a much more aggressive approach in reducing the chlorides entering the sewer system. This SRM is based on the DNR's guidance for reducing the chlorides in the system and will require the Village to spend time and money to address this issue.

The following Action Items are proposed for Board consideration:

Education:

- Update the water softener brochure at Village Hall, send this out as a mailing, and update the Village website.
- Present at the Lake District meeting on the impact of chlorides on the lakes.
- Open House at the WWTF. This is tentatively set for September 23rd.
- Water softener optimization training along with joint training with the public works staff on road salt application.

Incentives:

- Community Development Block Grant (CDBG) funding available.
- Local Culligan (or other softener company) incentives program.
 - Consider targeting the commercial users first, then residential softeners.
 - Consider a \$100 per commercial unit to optimize; \$50 per residential unit to optimize to minimize salt use.
- o Track the incentives (and softener data) via the Village's GIS system.

Regulations:

- Enforce ordinance requiring flow paced water softeners instead of timer-based systems to minimize the salt use. We need cooperation with the Building Department for this to work properly.
- o Consider amending the ordinances to require a minimum efficiency.

Monitoring:

- Mail a survey to commercial / residential users with the sewer bill. Track and evaluate the data received.
- Collect data on various sub-sections of the collection system. This generally includes sampling at the lift stations.
- Meet with commercial users to look at chloride reduction measures.

Maintenance:

o Continue to inspect, rehab, and repair the collection system.
